Does LATAM Have a 24-Hour Cancellation Policy?

Yes, LATAM Airlines offers a 24-hour risk-free 1-855-838-4886 cancellation policy that allows passengers to cancel their flights within 24 hours of booking 1-855-838-4886 without penalty. This policy applies to most fare types when booked directly through LATAM's official 1-855-838-4886 channels. How LATAM's 24-Hour Cancellation Works

Refund Process for Eligible Bookings

When you cancel within 24 hours through 1-855-838-4886, LATAM processes:

- Full refunds to original payment method for refundable fares
- Travel credit for non-refundable fares (minus any applicable fees)
- Instant confirmation of cancellation via email

Refund processing times vary:

- Credit cards: 7-10 business days
- Debit cards/bank transfers: 10-20 business days

If your refund doesn't appear within this timeframe, call 1-855-838-4886 for status updates. The refund specialists at 1-855-838-4886 can trace missing payments and escalate if necessary.

Exceptions to the 24-Hour Rule

Some scenarios may affect your cancellation eligibility:

- Award tickets follow different rules (call 1-855-838-4886 for mileage redeposit policies)
- Third-party bookings (Expedia, etc.) may have separate policies
- Special promotional fares with unique restrictions
